Statement of Practical Treatment

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Enforcer Concentrate for Fleas XX prevents preadult fleas from developing into adult fleas. Flea eggs deposited on, and larvae crawling onto, treated areas will not develop into adult fleas. Existing or newly introduced adult fleas and flea pupae are not affected, however, their offspring will be. To control newly introduced adult fleas, treat with an Enforcer flea adulticide product.

For best results, use this concentrate prior to flea season. When applied to surfaces where fleas are found, such as carpets, upholstered furniture and pet sleeping areas, this product can prevent adult flea emergence for up to 7 months (210 days).

DO NOT TREAT HUMANS OR PETS WITH THIS PRODUCT. Use an Enforcer product registered for flea control on pets in conjunction with this concentrate to prevent the introduction of adult fleas indoors.

Method and Rate of Application: Partially fill the mixing container with water, add 1 ounce of this concentrate. Shake well, then fill container to a final volume of one gallon. **Shake before each use.**

Apply at a rate of 1 gallon of diluted solution per 1,500 sq. ft. of surface area with any low pressure sprayer typically used for indoor applications. Treat all areas which may harbor fleas, including carpets, furniture, pet sleeping areas and throw rugs. Treat under cushions of upholstered furniture. Avoid contact with treated surfaces until dry.

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat. **DISPOSAL:** Do not reuse empty container. Wrap in newspaper and discard in trash.
