Hazards to Humans & Domestic Animals

CAUTION: Harmful if swallowed or absorbed through skin. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. Wash with soap and warm water after use. Avoid contamination of food or foodstuffs. Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding and floor cracks. Protects your home from reinfestation and total flea population; your pets and family from bites. A treatment with this spray can provide continuous flea protection for up to 120 days (4 months). Adult fleas reintroduced into treated area can be killed by retreatment. DIRECTIONS FOR USE

FLEAS, TICKS AND CARPET BEETLES: SHAKE WELL. Hold can 2 or 3 feet from surfaces to be treated. Evenly apply a fine mist or spray (avoid wetting or soaking) to carpets, rugs, drapes and all surfaces of upholstered furniture by using a wide, sweeping motion. Treat pet bedding, a primary hiding place for fleas. No need to remove pet bedding after treatment. Retreat as necessary. **DO NOT TREAT PETS.** Use an Enforcer product registered for flea control on pets in conjunction with this treatment. Do not allow contact with treated areas until completely dry.

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat, flames and other sources of ignition. **DISPOSAL:** Replace cap, wrap container in newspaper and discard in trash. Do not puncture or incinerate.
