It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding and floor cracks, and ultimately protects your home from reinfestation while protecting your family and pets from bites. A treatment with this spray can provide continuous flea protection for up to 120 days (4 months), and leaves no objectionable odor or sticky mess. When used as directed, this product will not stain furnishings or carpeting.

The pupae (cocoon) stage will not be affected by this product because the cocoon is very difficult to penetrate. Repeat treatments may be necessary to kill newly emerged fleas from the pupae stage.

FLEAS AND TICKS: SHAKE WELL. FOR INDOOR USE ONLY. Hold can 2 or 3 feet from surfaces to be treated. Evenly apply a fine mist of spray to carpets, rugs, drapes and all surfaces of upholstered furniture by using a wide, sweeping motion. Be careful not to saturate surfaces. Treat pet bedding, a primary resting place for fleas. No need to remove pet bedding after treatment. Retreat as necessary. **DO NOT SPRAY HUMANS OR PETS WITH THIS PRODUCT.** Use an Enforcer product registered for flea control on pets in conjunction with this treatment. Do not allow contact with treated areas until completely dry.

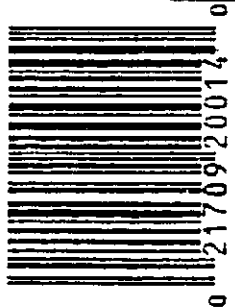
