**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product inconsistent with its labeling.

May be used full strength or diluted with 2 parts water.

Thoroughly soak animal with warm water taking 2-3 minutes to wet hair. Do not apply shampoo around eyes. Apply shampoo on head and ears, then lather; repeat procedure with neck, chest, middle and hindquarters, finishing legs last. Let animal stand 3-5 minutes (this is an important part of the grooming procedure), then rinse animal thoroughly. Repeat treatment immediately on extremely dirty or scaly animals; otherwise, do not reapply product for 7 to 10 days. Do not use on puppies or kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals.

**Storage and Disposal**

**Storage:** Store in a cool, dry place (preferably locked) inaccessible to children and pets. **Disposal:** Do not reuse empty container. Wrap and put in trash.
