I. Acute Toxicity Studies

The Agency has completed its review of the submitted Primary Dermal Irritation study (MRID No. 440614-03) and found it acceptable. Based on the results of the study, the subject product has been classified in Toxicity Category TII for dermal irritation potential. A copy of the Agency's review is enclosed for your records.

The Agency will review the submitted Acute Inhalation (MRID No. 440614-01) and Primary Eye Irritation (MRID No. 440614-02) studies in connection with product reregistration.

II. Label Amendment

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Under Hazards to Humans and Domestic Animals:
 - 1a. Add the statement "Causes eye irritation" after the signal word ("CAUTION").
 - 1b. Revise the statement which reads "Avoid contact with skin" to read as follows: "Avoid contact with skin, eyes or clothing."

WHERE TO USE

As a lawn edger, around patios, driveways, paths and walkways, for weeds in tree wells, around shrubs and flower beds, around and beneath fences; over ground covers such as gravel, bark or peat moss, on parking lots and other similar non-crop areas where weeds become troublesome.

USE FOR "SPOT" WEED CONTROL

Use as a "spot weed treatment" in lawns or at the edges of areas wherever weeds or creeping grasses, such as Bermuda or St. Augustine, present a problem. For best results, treat the center growth of weeds in the early growing stage when moisture and high temperatures are promoting vigorous growth.

PARTIAL LISTING OF WEEDS: Annual Blue Grass, Chickweed, Crabgrass, Florida Pusley, Foxtail, Garden Spurge, Goosegrass, Henbit, Knotweed, Lambsquarter, Mayweed, Oxalis, Pigweed, Prickley Lettuce, Purslane, Puncture Vine, Redroot Pigweed, Sandspur, Shepards Purse, Sowthistle, Smartweed, St. Augustinegrass, Velvetweed, Wild Geranium and grasses which creep over, under or around lawn edging; and that have grown-up through paved patios, walkways and driveways such as Bahia Grass, Bermudagrass, Centipedegrass, St. Augustinegrass and Zoysiagrass.

GENERAL INFORMATION

This product is a ready to use effective general weed killer which provides control of annual weeds and grasses. It gives effective top kill of troublesome perennial broadleaf weeds. One treatment will kill susceptible annual weeds. Respray perennial weed "top-growth" if patches of green reappear. If perennial weeds growth is a serious problem, ask your Dealer for a "residual" or a "bare ground" type weed killer.

HOW TO APPLY

Shake contents. Apply directly from this container by pointing down at weeds or grass to spray, using enough liquid to completely wet the weed or grass foliage that you want to kill. Kills the above ground weed and grass growth as a contact killer. Desirable plants, if accidentally sprayed, may be saved by immediately washing off the spray or pruning the area touched by the spray.

HOW TO APPLY AS AN EDGER

SHAKE WELL BEFORE USING. Remove cap from applicator head and be certain that the applicator head is screwed firmly on the jug. Invert the jug and apply product to thoroughly cover unwanted vegetation. The width of the spray pattern may be adjusted by either raising or lowering the jug. For top killing vegetation around trees, shrubs and buildings and edging around lawns, fences and sidewalks, hold the jug about 2 to 6 inches from the area to be treated depending upon desired width.

For controlling weeds in brick and gravel walks and patios or in other unconfined areas, hold the jug near waist high and away from the body to avoid contact with skin or clothing. Walk slowly. Make sure all undesirable vegetation are thoroughly covered. One gallon will cover a band 2 inches wide and 1,200 feet long.
