

#### **DIRECTIONS FOR USE**

#### APPLICATION DIRECTIONS FOR FLEA CONTROL SHAKE WELL BEFORE OPENING

CARPETS: Treat one room at a time. Vacuum all carpeted areas thoroughly and dispose of vacuum bag. Use caution during application as powder will flow freely. Apply to dry surfaces only, at the rate of one pound per 300 square feet. Apply evenly on all carpeted areas, including closet floors, under furniture, and where pets frequently traffic or sleep. Work powder deeply into fibers and mat with a broom or rug rake. Any visible powder after application must be brushed into carpet fibers, removed or vacuumed.

#### ALLOW THREE TO FIVE WEEKS FOR MAXIMUM FLEA CONTROL

**NOTE:** If a high adult flea population exists in the home, you may want to apply a pesticide (or an insert name of a product registered for adult flea control) registered to kill adult fleas before using this product.

**UPHOLSTERY:** Remove loose cushions of upholstered furniture. Clean and vacuum furniture wells thoroughly. Apply powder along creases and into corners and furniture wells. Do not apply product to exposed fabric. Work powder deep into wells and the surrounding fabric until it disappears. Any visible powder after application must be removed by vacuuming before replacing cushions. Reapply as necessary.

#### STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Do not store where children or animals may gain access.

DISPOSAL: Do not reuse container. Wrap and put in trash.

#### STATEMENT OF PRACTICAL TREATMENT
