These are vague or non-specific terms implying unstated benefits or heightened efficacy and are not acceptable. Also delete "highly active" from the claim, "Contains Deltamethrin-the highly active third generation pyrethroid". The claim, "New Formulation", may be used on the product labeling for a period of six months from the date of this Notice of Registration.

c. On the front panel, following the bullets listing pests, insert the following statement: "Not for use on plants grown for sale or other commercial use."

d. Delete the claim for ticks from "Kills Fleas and Ticks". The lowest concentration for which we have effectiveness data is 50% higher than that in the subject product. Also, delete directions for treating ticks from directions for use. Alternatively you may revise application instructions on product labeling to ensure delivery of a rate that will support the cliam for ticks.

e. In the Environmental Hazards section, add the following: "This product is highly toxic to bees exposed to direct treatement or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area."

f. Insert a Physical/Chemical Hazards section immediately below the Environmental Hazards section, with the following text: "do not apply this product in or on electrical equipment due to possibility of shock hazard."

g. Under DIRECTIONS FOR USE on page one of the labeling, revise the first sentence following the list of pests under "INDOORS:" to read as follows: "Apply as a spot and crack & crevice treatment to areas where these pests crawl and hide, especially in hidden areas around sinks...". Directions to "apply thoroughly to all areas where these pests crawl and hide," contradict the general information provided above, directing the user to apply to surfaces only as a spot and crack & crevice treatment.

h. Also under INDOORS, add the following before the retreatment statement: "Cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after
