Dear Ms. Hawkes,

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

1. The Signal Word "CAUTION" is required to appear on the front panel of the label, directly below the Child Hazard Warning statement (Keep Out of Reach of Children) and also on any supplemental labeling intended to accompany the product in distribution or sale. It must also be located in the Precautionary Statements section immediately below the subheading "Hazards to Humans and Domestic Animals" and in the WPS statement box, if one is on the label. In cases where the First Aid and Hazards to Humans and Domestic Animals do appear on the front panel, the Signal Word must be placed directly below the Child Hazard Warning statement, but does not have to be repeated after the "Hazards to Humans and Domestic Animals" statement. All required front panel warning statements shall be grouped together on the label, and shall appear with sufficient prominence relative to other front panel text and graphic material to assure that they will not be overlooked under customary conditions of purchase and use. In addition, the Signal Word must appear in all capital letters and be oriented in the same direction as other label text.


2. The term "Liberally" within the Directions for Use, should be replaced with a specific amounts. The units must not suggest the use of tablespoons, teaspoons, or other common household kitchen utensils, or containers. In addition, specific reapplication intervals should be listed on the label. Such information provides the user with detailed information on how much and when the product should be applied.

This product may be used in homes, restaurants, markets, schools, warehouses, factories, offices, hotels, motels, hospitals, nursing homes, garages, grocery stores, apartment buildings, new construction, industrial plants, theaters, ships, boats, trains, trucks, yachts, campers, mobile homes, buses, zoos, kennels, military bases, libraries, utilities and sewers. Reapply as necessary, as degree of infestations may vary. Brush powder visible after application into cracks and crevices or remove. Apply only in areas inaccessible to children and pets. Do not use in edible product areas of food handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not contaminate feed and foodstuffs.

To control cockroaches, ants and silverfish: Liberally apply, scattering under and behind refrigerator, stove, sink, dishwasher, washing machine and dryer, tubs; into openings around drains, water pipes and electrical conduits; and in cracks and crevices along baseboards and corners of cabinets, cupboards and closets. Remove all lower drawers in kitchen and bathroom cabinets, bedroom drawers and chests of drawers, then liberally scatter in drawer wells.

**Directions for Applying in New Construction to Control Cockroaches:** When treating large areas, such as wall voids, soffit and subcabinet voids in new and existing construction, liberally dust using suitable dusting application equipment.

**Directions for Applying as a Mop Solution to Control Cockroaches:** Add 1 cup of powder to each gallon of rinse water. Apply only to floor areas. Make only enough for each application. This is a Supplemental treatment to good housekeeping practices and other conventional roach control methods.

### Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store in cool, dry (preferably locked) storage area inaccessible to children and pets. **Disposal:** If Empty: Do not reuse this container. Place in trash or offer for recycling.
