

G-7300 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.9 G-7300 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 G-7300 per 1000 gallons every 1 to 5 days, or as needed. The frequency and relative amount of bleedoff and the severity of the additions should be made in the sump of water.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Do not store in five drum high. Drums should be opened in well-ventilated areas. Damaged drums should be stored in overpack drums. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
