Apply liberally, scattering under and behind refrigerator, stove, dishwasher, dryer, washing machine, around water pipes, in cracks and crevices, under and behind cabinets along walls, radiator, enclosed sinks, around sewers, manholes, water pipe traps and drains. Remove all lower drawers in kitchen, bath and closets and scatter liberally in drawer wells. Spread not more than 1/2 teaspoonful in corners of shelves in kitchen, bath and closets. Any powder visible after application, should be carefully brushed into cracks and crevices, or else removed. FOR A BAITED TRAP: Spread 1 teaspoonful of powder on 1/2 slice of fresh bread leave bait in emptied container in a high place out of reach of children and pets. In seven days remove container and discard out of reach of children and pets.
