STATEMENT OF PRACTICAL TREATMENT: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

Procide-35 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 1 Procide-35 per gallon is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 0.5 Procide-35 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store five drums high. Drums should be opened in a well-ventilated area. Damaged drums should be placed in overpack and should be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes, sludge, excess pesticide, spray mixture, or rinsate is a separate waste and cannot be disposed of by use according to the label. State Pesticide or Environmental Control Agency representative at your EPA Regional Office for disposal instructions.

CONTAINER DISPOSAL:
