

FIRST AID: If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or, if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Keep out of lakes, streams, or ponds. Permits may be required for discharges containing this pesticide into lakes, streams, ponds, or public water. For guidance, contact the regional office of the Environmental Protection Agency.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Procide-60 is used to control bacteria and fungi in recirculating commercial and industrial water systems. Upon its use, systems must be cleaned to remove slimes, and other deposits. An initial slug addition of 8 fluid ounces of Procide-60 per 1000 gallons of water to provide a concentration of 8 Procide-60, based on the volume of water in the system, is recommended. Repeat initial slug additions of 0.2 Procide-60 per 1000 Procide-60 parts per million of Procide-60 should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the sum of Procide-60 is used for air-washing systems that maintain effective microorganisms to its use, systems should be cleaned to remove deposits. An initial slug dose of 3.33 Procide-60 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. Repeat initial dosage until control is achieved. Repeat initial dosages of 2.25 to 5.55 fluid ounces of Procide-60 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made in the sum of collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking drums should be disposed of in a sanitary landfill, by incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.

PESTICIDE DISPOSAL: Wastes resulting from the use of this pesticide should be disposed of in a sanitary landfill, by incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.

CONTAINER DISPOSAL:
