

DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide inconsistent with its labeling.

MICROBICIDE - M is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 5.1 MICROBICIDE - M per 1000 gallons is recommended. Repeat initial dosage until control is effected. Subsequent slug additions of 1.7 MICROBICIDE - M per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

Disodium cyanodithioimidocarbonate 4.90 %
Potassium N-methylthiocarbamate 6.76 %

INERT INGREDIENTS 88.34 %

This product contains 1.03 lb. of active ingredients per gallon and weighs 8.88 lb. per gallon.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
STORAGE: Do not expose to extreme temperatures. Store in five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack and disposed of. Container should be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are considered hazardous. Do not use excess pesticide, spray mixture, or rinsate in a way that would cause wastes cannot be disposed of by use according to applicable State Pesticide or Environmental Control Agency regulations.
