

PHYSICAL AND CHEMICAL HAZARDS: Never mix chemicals together, but apply each seperately as directed.

DIRECTIONS FOR USE: INITIAL DOSE: One(1) gallon for each 37,000 gallons of water or 8 oz.( 1 cup) for each 2,200 gallons of water. Apply to freshly filled, clean pools.

CONTINUING DOSE: One quart for each 37,000 gallons of water every 2 days in warm, sunny or humid weather. Every 3 to 5 days in cool or cloudy weather.

BOOSTER DOSE: Add one(1) quart for each 37,000 gallons of water or 2 ozs. for each 2,200 gallons of water after a heavy or prolonged rainfall. Increase continuing dosage slightly or apply more frequently whenever the bathing load is unusually heavy.

The pool should be properly cleaned and filled with fresh water before beginning algicide treatment. However, if it is impractical to empty the pool and growth of algae is visible, use 1 gallon for each 7,500 gallons overnight. By morning, the withered algae will have fallen down or may be brushed to the bottom and then be swept out while the level of the pool is dropped one or two feet. Then apply the initial dose of 1 gallon in 37,000 gallons of water.

WADING POOLS: Use larger doses in wading pools because of the smaller amounts of water per bather. Add 2 oz. of Algicide Formula "A" for each 220 gallons of fresh water as pool is being filled. Repeat with 1 oz. fcr each 450 gallons every four days. In hot sunny weather, repeat every two days.

Algicide Formula "A" requires no specific equipment for applications. It may be poured directly into the water from any point around the pool oc through any water circulating system. At normal dosages, Algicide Formula "A" is compatible with all chemicals normally used in swimming pools. It will conserve their effectiveness.

Algicide Formula "A" is a concentrated solution of a quaternary ammunium chloride and is an effective agent to control the growth of algae in public and private swimming pools.


