DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

The normal injection of KARACIDE is 10 parts per million of the total fluid capacity of the system, (Example: For 100,000 gal. contaminated container use 1 gal. KARACIDE). In the event the system is drastically contaminated, with a seasonal infection of algae, bacteria, or fungus, the primary injection should be 30 parts per million. In the event there is not a definite reaction, after 72 hours repeat the 30 parts per million injection.

Basic treatment of 10 parts per million should be injected every 12 weeks to maintain this desireable condition.

KARACIDE should be sprayed on the surface of the container fluid. In the event this cannot be performed, inject during a filling process so it is uniformly mixed with the fluid of the system.

STORAGE AND DISPOSAL

Federal Law prohibits the re-use of this container. Do not rinse container. Destroy entire container when empty.
