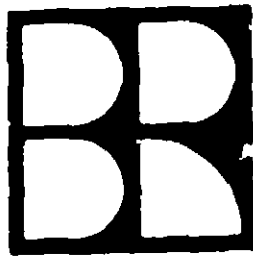

**FOR CONTROL OF FLEAS, TICKS & LICE ON DOGS AND CATS:**

**HOW TO USE** - Remove the Sprayer Cap and hold upright 4 to 6 inches from the animals coat. Pump the sprayer plunger to apply a fine mist to moisten the hair. To insure thorough coverage and spray penetration to the animals skin, part the fur by stroking against the lay of the hair as the spray is applied. Spray Ticks directly. Wear suitable latex gloves for this application.

Work from the rear legs, rump and belly towards the head making sure not to get spray in animals eyes, mouth or scrotum. Spray to slightly dampen the hair and skin. Repeat treatment as needed but not more often than once a day.

Animal bedding should be removed and sprayed thoroughly. Replace with fresh bedding. Treat the interiors of kennels (cracks and crevices where insects may hide) and other places where Ticks and Fleas may congregate. For problem infestations plan on a second treatment within 3 to 5 days. New animals which are accepted for boarding should be treated before placing in kennels. For difficult Lice infestations plan on dipping with a suitable EPA approved product directed for that use.

The above treatments will give temporary relief from Chiggers, Eye Gnats, Biting Flies and Mosquitoes. Repeat every 2 to 3 days as needed.
