

**PRECAUTIONARY STATEMENTS

DANGER**

Keep product dry in tightly closed container when not in use. Store in a cool, dry, well-ventilated area away from heat or open flame. Do not reuse empty container. Rinse empty container thoroughly with water to dissolve all material before discarding. Securely wrap container in several layers of newspaper and discard in trash.

**EMERGENCY HANDLING:** In case of contamination or decomposition do not re-seal container. If possible, isolate container in open and well-ventilated area. Flood with large volumes of water. Dispose of contaminated material in an approved landfill area.
