

**PRECAUTIONARY STATEMENTS  
HAZARDS TO HUMANS AND DOMESTIC ANIMALS  
DANGER**

Highly caustic. Causes skin and eye damage. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. Do not handle with bare hands.
