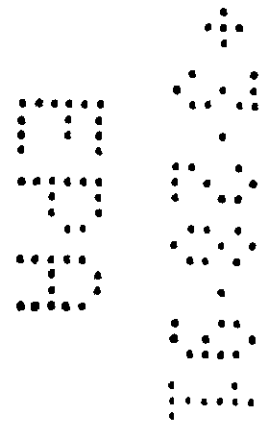

FOR INDOOR USE: In non-food areas of commercial and residential buildings. Do not use on electrical equipment or on surfaces that can be harmed or stained by water. Also for use indoors in dog kennels.

TO KILL FLEAS ON DOGS AND CATS AND IN ANIMALS QUARTERS:

Aids in the control of fleas on dogs and cats and on pet bedding and in horse stalls. Apply directly to animals along back, under fore legs and on other areas. Part hair to contact skin and insure good coverage. Hold nozzle about one foot away while spraying. Apply until hair is thoroughly moist. Do not directly spray in eyes or mouth of animal.

To reduce reinfestation, thoroughly spray the animal's bedding and other resting areas. Treat those areas at the rate of two seconds per linear foot while spraying at a distance of 12 to 18 inches. Also spray entire inside surface of dog houses. REPEAT AS NECESSARY.
