**TO KILL/REPEL FLEAS AND TICKS ON DOGS AND CATS:**

Spray directly on animals around neck, shoulders, along back, on abdomen, under forelegs and on other areas where insect infestation is observed. Hold sprayer about one foot away from animal during application. Apply until skin and hair are thoroughly moist, but not wet. Do not spray in eyes, nose or mouth of animal. Repeat as necessary.

**TO REDUCE REINFESTATION:**

Thoroughly spray the animal's bedding and other resting areas. Spray entire inside surface of dog houses. Repeat as often as necessary.

**STORAGE AND DISPOSAL:**

Store at temperatures above 32°F. Do not reuse empty container. Wrap container and put in trash collection.
