It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**Dip or Sponge Bath:** To control Ticks, Fleas and Lice on cats and dogs, dilute this concentrate at the rate of 1 fluid ounce to 1 gallon of water and mix well to form a creamy emulsion dip. Dip or sponge the animal with this solution being careful to thoroughly wet the entire animal. Do not rinse. Allow solution to remain on animal. Do not repeat treatment for one week. Do not treat kittens or puppies less than four weeks old.

**Kennel:** For control of insects in animal quarters and sleeping areas, dilute 1 ounce in to 16 ounces of water and spray as a coarse spray. Spray cracks and crevices and other places insects can hide. Remove and thoroughly spray bedding should be removed and sprayed thoroughly. Remove pets from area before treatment treating and ventilate before allowing pets them to re-enter.

**Storage:** Store in original container in a cool, dry (preferably locked) place, away from heat or open flame and inaccessible to children and pets in locked storage area. **Disposal: If empty:** Do not reuse this container bottle. Place Replace cap, wrap in newspaper and discard in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency [or 1-800-CLEANUP] for disposal instructions. Never place unused product down any indoor or outdoor drain.

<b>If on Skin or Clothing</b>	<ul style="list-style-type: none"> <li>• Take off contaminated clothing.</li> <li>• Immediately rinse skin with plenty of water for 15-20 minutes.</li> <li>• Call a poison control center or doctor for treatment advice.</li> </ul>
