The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1. Page 1 within the product attribute claims, remove the word "Natural" from the statement "Contains Natural Pyrethrins." This statement is false and misleading under 40 CFR 156.10.
- 2. Page 1 remove the statement "To be Applied only By or Under the Supervision of a Licensed Veterinarian or Animal Groomer." This statement is unenforceable under FIFRA, and the product is not a restricted use pesticide product. This statement is therefore, false and misleading under 40 CFR 156.10.
