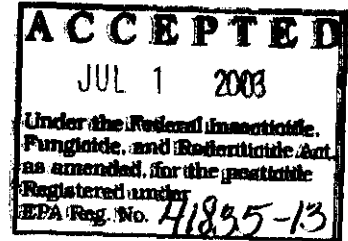

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use protective gloves or mitts to prevent contact with hands.

**Hold container upright. Shake well before using.**

This product kills fleas for up to 14 days on dogs and cats and kills ticks for 4 days on dogs and 9 days on cats.

For cats, apply at the rate of 1 second per pound of body weight. For dogs, apply at the rate of 2 seconds per pound of body weight for thin or short-haired dogs and up to 8 seconds per pound of body weight for heavy or long-haired dogs.

Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and underbody. Fluff the hair as you spray making sure the spray penetrates to the skin. Thoroughly wet ticks. Do not reapply for 14 days when treating for fleas. When treating for ticks, do not reapply for 4 days on dogs and 9 days on cats.

**Storage:** Store in original container in a cool, dry (preferably locked) place, away from heat or open flame and inaccessible to children and pets. **Disposal: If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency [or 1-800-CLEANUP] for disposal instructions. Never place unused product down any indoor or outdoor drain.
