

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive, causes irreversible eye damage and causes skin damage. Harmful or fatal if swallowed or absorbed through the skin. This product is a potential skin sensitizer. Workmen handling this product or treated material should wear impervious gloves, goggles or face shield, and protective clothing. All protective clothing, work shoes or boots, and equipment must be left at the work site at the end of the day. Eating, drinking, or smoking during use of this product is prohibited.

STORAGE: Do not expose to extreme temperatures. Do not stack more than five drums high. Drums should be opened in well-ventilated areas. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.

COOLING TOWERS: 905
wood against soft or surface rot and internal or dry rot. It is applied to wood surfaces containing 2.0 to 2.8% 905. The amount applied should provide 2.4 to 3.2 lb 905 per 1000 ft² of wood surface. Soft or surface rot can also be controlled by 905 to the recirculating cooling water. The dosage should provide 5.0 lb of 905 per 1000 gal of water and the bleedoff should be stopped for 4 to 6 hr after treatment repeated every four months.

COOLING WATER: 905
and fungi in industrial recirculating cooling water systems. Boilers should be cleaned thoroughly to remove old algal growth, microbial mats, and other debris. The system should then be drained, flushed, refilled with water, and treated with 905 per 1000 gal water of 0.8 to 4.8 fl oz per 1000 gal should be made every 1 to 5 days, depending on the severity of microbiological fouling.

DRILLING FLUIDS: To inhibit bacterial and fungal degradation of drilling of wells, 905 is used at concentrations of 0.2 to 1.0% based on the total wet weight of the fluid.

PETROLEUM SECONDARY RECOVERY: 905
control sulfate-reducing bacteria, slime-forming bacteria and other oil field water problems. 905 per 1000 gal of water made continuously or intermittently by means of a metering pump after injection pumps and injection well headers. Continuous flow of 15.6 to 52.0 fl oz 905 per 1000 gal of water until desired degree of control is achieved. The 905 per 1000 gal of water control. Intermittent or Slug Method: When system is noticed fouled, add 15.6 to 52.0 fl oz 905 per 1000 gal of water and 1 to 4 times per week, or as needed to maintain control.

CRUDE AND REFINED OILS: 905
is used for the control of bacteria and fungi that cause the degradation of oil during storage. It should be added to the oil as it is being transferred to storage tank at the rate of 2.4 to 24.0 fl oz 905 per 1000 gal of oil. Addition should be made batchwise where mixing occurs or continuously at the transfer pump.
