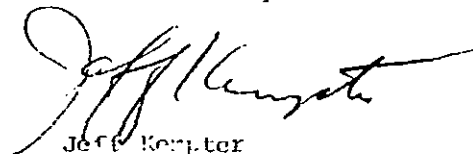

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ALC-300 is used to control algae and fungi in recirculating commercial and industrial water systems. Upon its use, systems must be cleaned to remove algae, slime, and other deposits. An initial slug addition of ALC-300 fluid ounces of ALC-300 per 1000 gallons of water to provide a concentration of 48 to ALC-300, based on

in the system, is recommended. Repeat initial dosage of ALC-300 Subsequent slug additions of 1.53 to ALC-300 per 1000 gallons

120 parts per million of ALC-300 employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the problem. Slug additions should be made in the sump of water.

ALC-300 is used to clean air-washing systems that maintain effective mist eliminators. Upon its use, systems should be cleaned to remove deposits. An initial slug dose of 24.7 to ALC-300 per 1000

gallons of water should be employed each 1 to 2 weeks. Repeat initial dosage until control is evident. Subsequent slug additions of 16.9 to 41.2 fluid ounces of ALC-300 per 1000 gallons of water should be employed each 1 to 2 weeks. Frequency of addition depends upon the relative amount of the bacterial problem. Slug additions may be made in the collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking or damaged drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product should be disposed of in a sanitary landfill.

CONTAINER DISPOSAL:

- PLASTIC** (Triple rinse for equivalent). Then offer for recycling or reconditioning, or for incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.
