STATEMENT OF PRACTICAL TREATMENT

Scatter Morgro PEST MEAL around annual flowers and perennial shrubs bothered by slugs, snails, earwigs, ants, grasshoppers, cutworms, millipedes or sowbugs. Apply at the rate of 1# per 850 square feet. Bait in early spring before pests cause damage. Repeat every 2 to 3 weeks as necessary to control slugs, snails or cutworms. DO NOT APPLY TO FOLIAGE or other plant parts.

FOR ADULT STRAWBERRY ROOT WEEVIL:

Apply 1 teaspoon of PEST MEAL around the base of Strawberry plants, Rhododendrons, Camellias, Primroses, and Azaleas. Broadcast lightly on soil surface using 1# per 850 square feet. (DO NOT APPLY DIRECTLY TO PLANTS.) Apply in April or May only, or when weevil is in pupae stage. Repeat treatment in 2 to 3 weeks if hatching weevils continue to appear.
