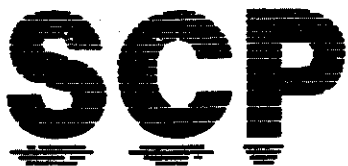

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness, pools, spas, whirlpools and hot tubs containing heavy growth of algae should be cleaned prior to using this product.

For pools having just visible algae growth, add an initial dose of 23.5 to 36.4 fluid ounces of this product per 10,000 gallons of water and remove settled algae debris by cleaning.

For treatment of a freshly cleaned and filled pool, add initially 12.8 to 23.5 fluid ounces of this product per 10,000 gallons of water. Subsequent additions of 4.3 to 8.6 fluid ounces of this product per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools and hot tubs having just visible signs of algae growth require an initial dose of 2 to 4 fluid ounces of this product per 1,000 gallons of water. For treatment of freshly cleaned spas, whirlpools or hot tub, add initially 1 to 2 fluid ounces of this product per 1,000 gallons of water. Subsequent additions of 0.5 to 0.8 fluid ounces of this product should be made every 5 to 7 days after initial treatment for maintenance.

This product is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. This product can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix with concentrated dry or liquid chlorine products.

Store in original container in a cool dry place. Do not reuse empty container. Wrap container and put in trash.
