For pools having just visible algae growth, add an initial dose of 11 to 17 fluid ounces of [this product]{or}[ brand name] per 10,000 gallons of water and remove settled algae debris by cleaning.

For treatment of freshly cleaned and filled pool, add initially 6 to 11 fluid ounces of [this product] or [brand]

name] per 10,000 gallons of water.

Subsequent additions of 2 to 4 fluid ounces of this product per 10,000 gallons of water must be made

every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools and hot tubs having just visible signs of algae growth require an initial dose of 1 to 2 fluid ounces of this product]{or}[ brand name] per 1,000 gallons of water.
