2. Revise the Directions for Use by including application directions of this product for exterior spas, whirlpools, hot tubs, decorative fountains and ponds that do not contain fish to read as follows:

Exterior spas, whirlpools, hot tubs, decorative fountains and ponds having just visible algae growth require an initial dose of 4 to 6 fluid ounces of this product per 1000 gallons of water. For treatment of freshly cleaned spas, whirlpools, hot tubs, decorative fountains and ponds, add initially 2 to 4 fluid ounces of this product per 1000 gallons of water. Subsequent additions of 1 to 2 fluid ounces of this product per 1000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is used to control the growth of algae in swimming pools, exterior spas, whirlpools, hot tubs, decorative fountains and ponds that do not contain fish.. For maximum effectiveness, pools, spas, whirlpools, hot tubs, decorative fountains and ponds containing heavy growth of algae should be cleaned prior to using this product.

For pools having just visible algae growth, add an initial dose of 37 to 56 fluid ounces of this product per 10,000 gallons of water and remove settled algae debris by cleaning.

For treatment of a freshly cleaned and filled pool, add initially 20 to 37 fluid ounces of this product per 10,000 gallons of water. Subsequent additions of 7 to 13 fluid ounces of this product per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

This product will prevent the growth of most algae during the off-season winter months when pools are not in use. For pools which have been properly treated during the swimming season and are free of visible algae, add 20 to 32 fluid ounces of this product per 10,000 gallons of water. If at the end of the swimming season pools have some visible algae growth, add 37 to 57 fluid ounces of this product per 10,000 gallons. It is necessary that a uniform distribution of the product throughout the water and the pool be made for maximum effectiveness. If the pool is not covered, it may be necessary to repeat the treatment one or more times during the season.

This product is compatible with those chemicals normally used to treat pools and effective at both acid and alkaline pH. This product can be used in pools treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix this product with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

Store in original container in a cool dry place. Do not reuse empty container. Wrap container and put in trash.
