The Antimicrobials Division (AD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped "Notification" and will be placed in our records.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

The primary brand name "Microban Excalibur Concentrate" has been added to the product record and the previous primary brand name "Microban Microguard Concentrate" has been marked as inactive.

Plastics, fiberglass, metals, glass, wood, ceramics, stone, natural materials, composites: Including roofing materials (tiles, shakes, shingles, granules, stone, membranes, felt, underlayment and synthetic overcoats); building materials and components (including siding, wallboard, wood and wood composites, insulation and non-food contact cabinetry); ceiling tiles; concrete and concrete products (including wet cast, dry cast, and self-consolidating concrete (SCC) containing Ordinary Portland Cement (OPC), and/or Granulated Ground Blast-furnace Slag (GGBS) and/or silica fume and/or fly ash and which can be precast or formed-in-place);paints and coatings; mastics and sealants; cementitious materials (including caulk, grout and cement and grout premixes); non-food contact countertops; floor covering; flooring; bathroom and non-food contact kitchen hardware; plumbing supplies and fixtures; sheet and formed glass.

HOW TO USE:

Wear goggles or face shield, protective clothing, rubber gloves and respirator when handling the concentrated material. Use with proper ventilation. Undiluted Microban <u>Excalibur</u>Microguard Concentrate contains 12 percent methanol. Do not breathe vapors. Keep away from heat and open flame. Methanol is released during mixing, application and drying. If desired, methanol removal may be accelerated by heating dilute solution before treatment of substrate. Appropriate measures should be taken to prevent the accumulation of hazardous concentrations of methanol vapors in the work area.

Microban ExcaliburMicroguard Concentrate is for application to organic and inorganic surfaces as a dilute aqueous solution to give 0.1 to 1.0 percent by weight of active ingredients. Aqueous solutions are prepared by simply adding the antimicrobial agent to water with stirring. NOTICE: Poor agitation when adding this silane to water can result in locally high concentrations, which may form gel particles. Surfaces are to be treated with the aqueous solution by brushing, dipping, padding, soaking, spraying or fogging until adequately wet, or applying by foaming techniques. After applying treatment, the surface must be allowed to dry at temperatures from ambient to a maximum of 160°C (320° F) to effect complete curing of silanol groups and to remove water, solvents and/or traces of methanol from hydrolysis. Curing of polymer is accelerated or enhanced with heat or catalysis. For each application, determine optimum application and drying conditions, such as time and temperature before use. If desired, reapply Microban ExcaliburMicroguard Concentrate if odor, staining and discoloration due to bacteria, mold or mildew occur.

Incorporate Microban ExcaliburMicroguard Concentrate directly into formulations used to make end-use products, or dilute with water or with organic solvents such as alcohols, ketones, esters, hydrocarbons and chlorinated hydrocarbons and then apply it to the organic and inorganic surfaces to give 0.1 to 1.0 percent by weight of active ingredient.

For incorporated use as a grout or cement additive and in concrete and concrete products, add Microban ExcaliburMicroguard Concentrate directly to the dry mix during the grout, cement, or concrete preparation. Use 0.5 - 2 fluid ounces this product per 50 pounds of dry mixture. For concrete applications, use 6.4 - 32 fluid ounces of this product per cubic yard of concrete. Follow directions

for grout or concrete, using Microban <u>ExcaliburMicroguard</u> Concentrate as part of the added water. Addition of Microban <u>ExcaliburMicroguard</u> Concentrate inhibits the growth of odor causing bacteria, bacteria which cause staining and discoloration, fungi (mold and mildew), and algae on the surface of the cured grout and concrete.

STORAGE AND DISPOSAL:

Do not contaminate water, food, or feed by storage and disposal.

Storage and Disposal

Store in original, tightly closed container in an area inaccessible to children or persons unfamiliar with its use. Moisture sensitive. Reclose tightly after each use. Do not reuse container. Discard in trash.

Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

For drums: Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.
