DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.  
If bed has not been treated properly, drain bed completely. Add 15 gallons of water, mix vigorously, drain bed again. Fill bed with water and follow dosage directions.

**DOSEAGE:** To control growth of odor-causing and slime-forming bacteria, add 4 fluid ounces of Blue Magic® Waterbed Conditioner in a free flow waterbed of 90 to 180 gallon capacity. Add 8 fluid ounces of Blue Magic® Waterbed Conditioner in a wavyless/fiber waterbed mattress of 90 to 180 gallon capacity. Repeat application every 4 to 6 months.
