

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

DOSAGE: To control growth of odor-causing and slime-forming bacteria, add 4 fluid ounces of product in a waterbed of 90 to 180 gallon capacity. Add 2 fluid ounces in a twin or hybrid type bed up to 90 gallon capacity. Repeat application at 10 to 12 month intervals depending on local water conditions.

PRECAUTIONARY STATEMENTS

CAUTION: ~~Hazards~~ to humans and domestic animals.

Harmful if swallowed. Avoid breathing vapors. Avoid contact with skin, eyes, or clothing.
