This is in response to your label amendment for adding statements on the issue of waterbeds that are not treated/maintained properly.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy is enclosed for your records. Five copies of the finished labeling must be submitted before the product is released for shipment bearing the amended labeling.

1. In the Precautionary Statements, expand the statement, "Avoid contact with skin" to read, "Avoid contact with skin, eyes, or clothing."

2. In the Precautionary Statements, add the statement, "Avoid breathing vapors."

**DIRECTIONS FOR USE:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

If bed has not been treated properly, drain bed completely. Add 15 gallons of water, mix vigorously, drain bed again. Fill bed with water and follow dosage directions.

**DOSAGE:** To control growth of odor-causing and slime-forming bacteria, add 8 fl. oz. of this product to a fiber waterbed mattress of 90-180 gallon capacity. Add 4 fl. oz. to a twin or hybrid type waterbed up to 90 gallon capacity. Burp all air bubbles, then heat to desired temperature. After 4-5 days, burp bed again and close mattress valve tightly. Repeat application every 10-12 months in fiber or foam beds. In free-flow waterbeds, repeat application every 18-24 months.

**PRECAUTIONARY STATEMENTS**

**CAUTION:** Hazards to humans and domestic animals. Keep out of reach of children. Harmful if swallowed. Avoid contact with skin, eyes, or clothing.

**FIRST AID:** If swallowed, promptly drink a large quantity of milk, egg white, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately. If product comes in contact with skin or eyes, wash with plenty of water. For eyes, call a physician.

**ENVIRONMENTAL HAZARDS:** This pesticide is toxic to fish. Keep out of lakes, streams, ponds, or public water. For guidance, contact the regional office of the Environmental Protection Agency.
