

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

CLEANING AND DEODORIZING

HOUSEHOLD CLEANING: When mopping or scrubbing vinyl floors, remove heavy soil, use 1/4 cup of Pine Fresh for each gallon of water. Apply with mop or sponge. Discard solution when it becomes heavily soiled.

BATHROOM: For cleaning bathroom fixtures, such as wash tub, basin and toilet seat, use 1/4 cup of Pine Fresh for each quart of water. Wash fixtures with sponge or rag. Discard solution when it becomes heavily soiled.

DIAPER PAIL: Add 1/4 cup of Pine Fresh per 1 gallon of water in pail. Let stand and wash out with sponge or rag, empty, and rinse pail thoroughly.

DISINFECTING AGAINST ODOR CAUSING GERMS

Kills odor causing germs on hard, non porous surfaces such as toilets, wash tubs, diaper pails, and floors. Prior to disinfecting, remove heavy soil and clean surfaces thoroughly. Use 1/4 cup of Pine Fresh per 1 gallon of water and apply with sponge or mop. Let stand on surface for 10 minutes. Remove excess.
