- 1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Since this is a Manufacturing Use Product update the Environmental Hazards Statement to read as follows:

Environmental Hazards

Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the Environmental Protection Agency.

- b. On the same line as "Total Arsenic (as elemental) all in water soluble form" reinstate "16.3%".
- c. In the Hazards to Rumans section since this product is for formulating use ordy, delate "spray mist" and replace with "vapor". Also, delety "Reep children and domestic animals off treated areas until teshed into the soil".

2. Submit one (1) copy of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.

The revised basic formula dated 8/16/92 is acceptable and has been included in the files for this product. It supersedes all previously accepted ones.
