DORSAN (chlorpyrifos) is a cholinesterase inhibitor. Initial measures include removal of secretions, maintenance of a patent airway and, if necessary, artificial respiration. When cyanosis is relieved, atropine may be administered in large therapeutic doses, repeated as necessary to the point of tolerance. If symptoms warrant further treatment, protopam chloride (pralidoxime chloride, 2-PAM chloride) has shown utility as adjunctive therapy. Never use morphine. Continued absorption of the poison may occur, resulting in fatal relapse after initial improvement, very close supervision of the patient is indicated for at least 48 to 72 hours.
