The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

1. Add the following address to the label"

"Manufactured for: Luxembourg-Pamol, Inc. 5100 Poplar Avenue, Suite 2700 Memphis, TN 38137"

2. In the section **HAZARDS TO HUMANS AND DOMESTIC ANIMALS** add the following sentence after "Do not breathe dust and avoid contact with eyes and clothing.": "Wear a mask or pesticide respirator jointly approved by the Mine and Safety Health Administration and the National Institute for Occupational Safety and Health."
