

The Acta Group, L.L.C. (Acta) submits on behalf of Luxembourg-Pamol Inc. (Luxembourg) this notification to make the following changes to the label of the above-referenced registered product, Tegrol[®] Technical Fungicide. These changes are made pursuant to Pesticide Registration (PR) Notice 2007-4.

- 1. A statement identifying the container as a nonrefillable container and an appropriate container reuse has been added; and
- 2. A statement providing cleaning instructions for removal of residues prior to container disposal has been added.

Luxembourg understands that it is a violation of 18 U.S.C. Section 1001 to make willfully any false statement to the U.S. Environmental Protection Agency (EPA). RESTRICTIONS

DO NOT PACKAGE TEGROL® TECHNICAL IN METAL CONTAINERS.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food and feed. Store in original container and out of reach of children, preferably in a locked storage area.

For 5 gallons or more, triple rinse as follows:

Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Then offer for recycling or reconditioning, if available, or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
