This Product Controls: Aphids, Asparagus Beetles, Blister Beetles, Cabbage Loopers, Cross-striped Cabbageworms, Colorado Potato Beetles, 12-Spotted Cucumber Beetles, Diamond-back Moth Larvae, Flea Beetles, Fireworms, Harlequin Bugs, Imported Cabbageworms, Leaf Rollers, Leafhoppers, Mexican Bean Beetles, Rose Chafers, Stink Bugs, Striped Cucumber Beetles, Webworms, and Whiteflies.

For Use on These Plants: Asparagus, Beans, Broccoli, Brussels Sprouts, Cabbage, Cauliflower, Celery, Cranberries, Cucumber, Currant, Eggplant, Grape, Kale, Lettuce, Mustard Greens, Peppers, Potatoes, Radishes, Spinach, Squash, Strawberry, Tomatoes, and Turnips.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry area away from heat and open flame.
