

<u>Use as provided on vegetables, including:</u> asparagus, beans, broccoli, Brussels sprouts, cabbage, kale, and oriental vegetables, herbs, lettuce, eggplant, peppers, tomatoes, potatoes, cucumbers, melons and squash to control ASPARAGUS BEETLES, BEAN BEETLES, COLORADO POTATO BEETLES, CUCUMBER BEETLES, FLEA BEETLES, CATERPILLARS (including CABBAGE LOOPERS, IMPORTED CABBAGEWORM, ARMYWORMS, HORNWORMS, DIAMOND BACK MOTH LARVAE), LEAF HOPPERS, PLANT BUGS, PSYLLIDS, APHIDS AND WHITEFLIES. Use as provided on fruit and nuts, including: apples, avocados, citrus (grapefruit, lemons, oranges, tangerines, limes), peaches, nectarines, apricots, pears, almonds, pecans, walnuts, kiwi fruit, blackberries, loganberries, raspberries, strawberries and grapes to control JAPANESE BEETLES, FLEA BEETLES, WEEVIL ADULTS, CATERPILLARS (including NAVAL ORANGE WORM, BAGWORMS, LEAFTIERS, CODLING MOTH, and TENT CATERPILLARS), APHIDS, LEAFHOPPERS, PSYLLIDS, SCALE CRAWLERS, and SAWFLY LARVAE. <u>Use as provided on Flowers, including:</u> asters, carnations, chrysanthemums, geraniums, marigolds, petunias, and roses to control APHIDS, BEETLES, (including FLEA BEETLES and JAPANESE BEETLES), CATERPILLARS, PLANT BUGS, and WHITEFLIES.

# For use on Pets and premises (Pet areas):

To control fleas, ticks and lice on pets: Use as provided. SHAKE WELL. Begin spraying at tail and progress quickly over the rest of the animal, being sure to cover the entire body including legs and feet. While spraying, fluff the fur so that spray can soak the animal. Repeat as necessary. CAUTION: Do not get spray in the animal's eyes, mouth or ears. Do not spray genital area. Do not spray nursing females or animals under six weeks of age. If animal shows any signs of dermal irritation, discontinue use and bathe animal with a mild shampoo.
