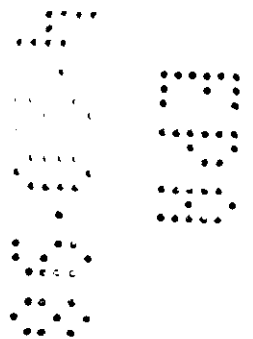

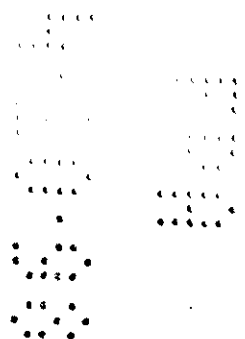

**USE:** Shake well. Use as provided for spot treatment of weeds. Adjust nozzle to give a coarse spray. Aim at center of weed and spray for thorough wetting and complete coverage of all unwanted vegetation. For most rapid kill, apply during warm, sunny weather when temperatures are 60° F or above. Best results will be obtained with spring or early fall applications when weeds are actively growing. Plants that have not emerged at time of application will not be controlled. Do not apply during windy conditions that will carry the spray to desired vegetation. Some hard to control weeds and grasses may require an additional treatment.

Safer® Brand SUPERFAST® Brand Weed & Grass Killer contains Safer® Brands Weed-Marker™ colorant. Treated areas will be marked by a yellow colorant making areas clearly visible. Weed-Marker™ helps you know where you have sprayed. This avoids overapplication to the same weed, missed weeds, and allows immediate detection of overspray onto desirable plants: if overspray occurs, immediately rinse off exposed plant surfaces with water. The Weed-Marker™ colorant breaks down quickly in sunlight and will be washed off by watering or rains. If SUPERFAST® Brand Weed & Grass Killer gets on desirable surfaces such as concrete, stone, wood, or paint, immediately rinse with water to prevent staining.

**NOTE:** Some visible staining may occur if product comes into contact with clothing or shoes. The stains are removed by normal laundering. Care should be taken when treating weeds in flower beds or around shrubs and ornamental plantings. Do not allow spray to come in contact with desirable plants as this product will kill most plants contacted. Do not spray exposed roots of desirable trees and plants. Do not use for spot treatment of weeds in lawns. Wait 3 weeks before seeding. Do not water within 24 hours after application. Watering will wash off herbicide. Do not apply if rainfall is expected within 24 hours after application. Avoid "fine-mist" sprays, coarse spray droplets are less likely to drift. Spray when air is calm to avoid spray drift that might injure desirable ornamental plants.

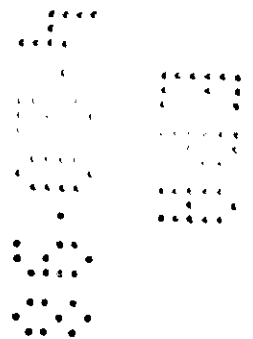
