If Canada thistle is present, up to 3/4 pint per acre may be necessary for control. Flax may be injured at this higher rate.

PASTURELAND

Grassland (Established grassland: Aerial and surface applications): Use 1 to 3 pints per acre in sufficient water (10 to 100 gallons) for thorough coverage Use higher rate for Whitetop, Canada thistle and other less susceptible weeds. Spray perennials in early bud to full boom stage and during active regrowth in fall. Other weeds may be controlled during spring or fall 'hen actively growing.

Grasses (Grown for Seed: Aerial and surface applications): Use 1 to 2 pints per acre, the higher rate where weed stands are heavy. In established grasses, apply in spring befo e head comes into boot and on seedling grass after grass has tilllered.
