

Required label changes for the registration of Albaugh Bromoxynil Octanoate Technical, 42750-51.

1. Change signal word from CAUTION to WARNING.
2. Replace the text under "Hazards to humans and domestic animals" with:  
 May be fatal if swallowed or absorbed through skin. Harmful if inhaled. Causes moderate eye irritation.  
 Avoid breathing (dust, vapor or spray mist). Do not get in eyes, on skin, or on clothing. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash clothing before reuse.
3. We suggest that you revise the label text to conform with the forthcoming Consumer Labeling Initiative PR notice by replacing the text under "Statement of Practical Treatment" to:
