- 3. Submit the following studies: Oxidation/Reduction: Chemical Incompatability (830-6314), Storage Stability of Product (830-6317), and Corrosion Characteristics (830-6320) are outstanding. These data are due within 8 months of the date of this Notice.
  - b. The Agency has recently revised its recommended First Aid statements for pesticide products (refer to PR Notice 2000-3: First Aid Statements on Pesticide Product labels). The new statements were developed as part of the Consumer Labeling Initiative in close cooperation with poison control center personnel and other medical experts. While it is not mandatory that you revise your label at this time, you are strongly encouraged to substitute the revised statements (see enclosure) for those statements currently on the label at your next printing. If you wish to receive a stamped copy of the label with the revised First Aid statements, submit an application for amendment (EPA Form 8570-1) and 4 copies of draft labeling for our review.
- 4. Submit one copy of the revised final printed label for the record before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec.6(e). Your release for shipment of the product constitutes acceptance of these conditions.

#### DIRECTIONS FOR USE
