## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS:

**DANGER:** Corrosive. Causes severe eye damage. May be fatal if inhaled; do not breathe dust. May be a potential skin sensitizer. Do not get in eyes or on clothing. Harmful if swallowed or absorbed through the skin,

### DIRECTIONS FOR USE

**Note to user:** Chlorothalonil Technical may produce temporary allergic side effects characterized by redness of the eyes, mild bronchial irritation and redness or rash on exposed skin areas. Persons having allergic reaction should contact a physician.

**For Formulation Purposes Only:** This product is intended for use only by formulators in preparing end-use fungicides.

**When manufacturing wettable powder formulations:** This product may only be used to manufacture wettable powder formulations that 1) are packaged in water soluble packets the outside of which contain a pictogram depicting that users should not cut, rip or tear; or 2) bear the labeling "For use in closed mixing/loading systems only".

This product must not be formulated into products labeled for home lawns.

This product may be formulated into end-use fungicides having the following use sites:

#### 1) Field and row crops:

beans (snap and dry), cabbage and other cole crops, carrots, celery, corn, cranberry, cucurbits, grasses grown for seed, mint, onion (garlic, leek, shallots), papaya, parsnip, passion fruit, potato, soybean, and tomato.

#### 2) Fruit and tree crops:

Stone fruit (peach, nectarine, apricot, cherry, plum); pine and spruce in forest stands, Christmas tree plantations, and nurseries.

**3) Ornamental plants:**

A wide range of ornamental plant species grown in field, nursery and greenhouses.

**4) Grasses grown on sod farms, golf courses (tees, fairways, greens) and municipal parks.**

This product must not be formulated into a product intended as a mildewcidal paint additive for direct sale to retail customers, e.g., in a 'pillow pack' or other small volume or one-use package. This product must not be used to formulate products for use as in-container preservatives.

This product may only be formulated into mildewcidal paint additive products that are labeled as follows "This product may only be added to paint products that are labeled A) with product-specific instructions for the use of a respirator during application, or B) as follows "When applying with a sprayer, wear a dust/mist filtering respirator (MSHA/NIOSH approval number TC-21C) or a NIOSH approved respirator with any R, P, or HE filter."
