Dear Mr. Gaskins:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. Per the HED risk assessment, dated November 6, 2012, the following comments apply:

1. An analytical reference standard for quinclorac, the quinclorac methyl ester, and quinclorac DMA salt must be submitted to the EPA National Pesticide Standards Repository.
2. Further expansion of the use of quinclorac to other commodities grown on larger acreage than rhubarb and cranberry will trigger a requirement of additional metabolism data.

Amended labeling will supersede all previously accepted ones. A stamped copy of labeling is enclosed for your records. Submit one (1) copy of final printed labeling before you release the product for shipment.
