Dear Mr. Gaskins:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

1. Under terrestrial food crops delete plantains, pistachios and soybeans.
2. Under terrestrial food crops, revise "barley" to read "barley (seed and foliar treatment)" and revise "wheat" to read "wheat (seed and foliar treatment)".


As a condition of registration, you must submit or cite data to satisfy the following data gaps in the timeframe specified below:

1. Submit barley field trial data from regions 10 and 11 (along with concurrent storage stability data on barley straw). Submission Due by: December 2011
2. Comply in the timeframe specified with the future Agency Data Call-in for all triazole-derivative active ingredients.
3. Submit a Whole Sediment Toxicity Study for benthic invertebrates. Submission due by: December 2011.
4. Submit Aerobic and Anaerobic Aquatic Metabolism Studies. Submission due by: December 2011.

One copy of the label stamped "Accepted with comments" is enclosed for your records. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.

For specific information on federally registered uses, contact Albaugh. Any variance from the federally registered labeling for products containing Tebuconazole Technical will have to be supported by data provided by the formulator.

Tebuconazole Technical fungicide is intended for formulation into end-use products for:

##### Terrestrial Food Crops:

Bananas, Barley, Cherries, **Grapes**, Grasses grown for seed, Nectarines, Oats, Peaches, Peanuts, **Pistachios**, **Plantains**, **Soybeans** and Wheat.

##### Terrestrial Non-Food Crops:

**Roses, Flowers, Ornamental trees, Ornamental shrubs, Groundcovers, House Plants, and Vines**

##### Terrestrial Non-Food (Domestic Outdoor):

**For the preservation of wood-based composite products and wood products intended for above ground and in-ground contact.**

#### RESTRICTIONS

Do not package Tebuconazole Technical in metal containers.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

Handle and open container in a manner as to prevent spillage. If the container is leaking or material spilled for any reason or cause, carefully sweep material into a pile. Refer to Precautionary Statements on label for hazards associated with the handling of this material. Do not walk through spilled material. Dispose of pesticide as directed below.
