Subject: Labeling Amendment; Clarification of Increased Applications Rates for Trees Imidacloprid 75WSP T&O EPA Registration No. 42750-117 Submission Date: January 26, 2010

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended is acceptable provided you make the following changes:

- 1. On page 7 of the label, delete "Borers (Including Two-lined Chestnut borer, Bronze birch borer, Asian longhorned beetle, Emerald Ash borer)". Foliar applications are not appropriate for the treatment of borers. These pests may be retained within the SOIL APPLICATION section of the label.
- Within the list of pests, located directly under the header SOIL APPLICATION TO NON-BEARING FRUIT & NUT TREES, SHRUBS, FLOWERS AND GROUNDCOVERS (pages 7 & 8), delete "Asian longhorn beetle". In addition, revise "Roundheaded borers" to read "Roundheaded borers (including Asian longhorned beetles)".
- 3. Within the list of pests, located directly under the header SOIL APPLICATION TO NON-BEARING FRUIT & NUT TREES, SHRUBS, FLOWERS AND GROUNDCOVERS (pages 7 & 8), delete "Emerald Ash Borer". In addition, revise "Flatheaded borers (including bronze birch and alder borer)" to read "Flatheaded borers (including bronze, alder and emerald ash borers)".
- 4. Within the list of pests, located under the header **TREES** (page 8), revise "Asian longhorn beetle" to read "Asian longhorned beetle".
- 5. The label contains two separate sections for applications to turf grass. The first section starts on page 4 and continues onto page 5, while the second section is located on page 6. The two turf grass sections are separated by an unrelated section dealing with applications to ornamentals. Having two sections for turf grass is unnecessary as information on pests controlled and

restrictions are repeated multiple times. The two sections must be revised into one, concise section for turf grass.

6. Due to this product being packaged in water-soluble bags, the **CONTAINER DISPOSAL** section of the label (page 3) must be revised to read as follows:

)

CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container. **Outer Packaging:** Outer packaging for this product is secondary packaging to contain water soluble plastic bags. Thoroughly rinse any soluble powder residue from container into application equipment; then offer for recycling if available or dispose of in a sanitary landfill. **Water-soluble Plastic Bags:** After adding water-soluble plastic bags to the application equipment, allow sufficient time for bags to dissolve before applying. There is no container disposal once the bag has been dissolved.

IMIDACLOPRID 75WSP T&O will suppress cutworms and chinch bugs.

IMIDACLOPRID 75WSP T&O can be applied on turfgrass in the following sites:

RESTRICTION: *Use not permitted in Arizona unless otherwise directed by supplemental labeling.

IMIDACLOPRID 75WSP T&O has adequate residual activity that applications can be made preceding the egg laying activity of the target pests.

Best control is achieved when applications are made prior to egg hatch of the pests and when rainfall or irrigation after application will penetrate vertically in the soil column carrying the active ingredient into the zone where insects are normally located.

RESTRICTION:

- Do not exceed a total of 8.6 ounces application (0.4 lb of active ingredient) per acre per year.
- Do not apply when infested turfgrass areas are waterlogged or soil beneath turf is saturated with water.

APPLICATION EQUIPMENT FOR USE ON TURFGRASS

Dilute IMIDACLOPRID 75WSP T&O with enough water to provide adequate volume to promote thorough distribution into the pest zone. Use only accurately calibrated equipment for application to turfgrass. Apply a uniform, coarse droplet spray, using a low pressure setting to eliminate off target drift. Perform calibration on a regular basis to ensure that equipment is distributing product properly.

APPLICATION TO ORNAMENTALS

IMIDACLOPRID 75WSP T&O can be applied to ornamental plants in commercial and residential landscapes and interior plantscapes. IMIDACLOPRID 75WSP T&O is a systemic insecticide that is transported within the plant system from the roots to upper foliage. IMIDACLOPRID 75WSP T&O must be applied into a growing area of the plant that allows absorption of the active ingredient. Adding soluble nitrogen type fertilizers to the spray solution when appropriate can promote the uptake of the active ingredient.

Application can be made by foliar application or soil applications; including soil injection, drenches, and broadcast sprays. Foliar applications offer locally systemic activity against listed insect pests.

The systemic translocation of active ingredient will be slower when applied to woody plants with soil applications. This delay can take 60 days or longer depending on species and size of plant. To offset this, make applications before anticipated pest infestation.

RESTRICTION: For outdoor ornamentals, applications cannot exceed a total of 8.6 ounces (0.4 lb of active ingredient) per acre per year.

ANT MANAGEMENT PROGRAMS

Using IMIDACLOPRID 75WSP T&O to control aphids, scale insects, mealybugs and other sucking pests on ornamentals will reduce ant populations because it removes honeydew as a food source. To enhance control of ants, supplement with residual sprays, bait placements or other ant control tactics.

APPLICATION EQUIPMENT FOR FOLIAR APPLICATIONS

IMIDACLOPRID 75WSP T&O mixes readily with water and may be used in many types of application equipment. Add a commercial spreader/sticker promote coverage on hard to wet foliage such as holly, pine, or ivy.

IMIDACLOPRID 75WSP T&O is compatible with many commonly used fungicides, miticides, liquid fertilizers, and other insecticides. If applicator has no prior experience with a particular tank mix; check physical compatibility by making a small clear jar test using correct proportions of products to be tank mixed.

RESTRICTIONS

- Keep children and pets off treated area until dry.
- Do not apply more than 8.6 ounces (0.4 lb of active ingredient) per acre per year.
- Not for use in commercial greenhouses, nurseries, or on grasses grown for seed, or on commercial fruit and nut trees.
- Do not graze treated areas or use clippings from treated areas for feed or forage.
- Do not apply through any irrigation system
- Do not allow puddling of irrigation water following application.

• For crops not listed on an imidacloprid label, or for crops for which no tolerances for the active ingredient have been established, a 12-month plant-back interval must be observed.

TURF GRASSES

TO CONTROL LARVAE OF:

European Crane Fly Annual bluegrass weevil Green June beetle Asiatic garden beetle Japanese beetle Billbug Northern masked chafer Black turfgrass ataenius Oriental beetle Cutworms (suppression) Phyllophaga spp. European chafer Southern masked chafer

Apply 1.6 ounces (1 packet per 8,250 to 11,000 sq ft). Make application prior to egg hatch of grubs, billbugs, annual bluegrass weevil, and European Crane Fry to maximize control.

For chinch bugs (suppression) and mole crickets apply 1.6 ounces (1 packet) per 8,250 sq. ft. For suppression of chinchbugs, make application before the hatching of the first instar nymphs.

For control of mole crickets make application before or during the peak egg hatch period. If adults or large nymphs are actively tunneling, combine applications of IMIDACLOPRID 75WSP T&O with a remedial insecticide. Follow label instructions for other insecticides when tank-mixing.

Consult your local turf, state Agricultural Experiment Station, or State Extension Service Specialists for more specific Information regarding timing of application.

In order to move the active ingredient through the thatch, irrigate if rainfall does not occur within 24 hours after application.

RESTRICTIONS FOR TURF GRASS:

- Do not apply more than 8.6 ounces (0.4 lb of active ingredient) per acre per year.
- Do not mow turf or lawn area, until after adequate irrigation or rainfall has occurred.

FOR FOLIAR APPLICATION TO NON-BEARING FRUIT & NUT TREES, SHRUBS, EVERGREENS, FLOWERS, FOLIAGE PLANTS, GROUNDCOVERS AND INTERIOR PLANTSCAPES

(Only for Industrial, Commercial Buildings, Residential and Landscaped Areas)

TO CONTROL:

Apply 1.6 ounces (1 packet) of Imidacloprid 75WSP T&O per 300 gallons of water. Make foliar applications before high pest populations become established. Reapply on an as needed basis.

To control White grub larvae, (such as Japanese beetle larvae, Chafers, Phyllophaga spp. Asiatic garden beetle, Oriental beetle) apply 1.6 ounces (1 packet) per 8,250 to 11,000 sq ft.

Make broadcast applications by mixing specified rate in enough water to uniformly cover the treated area. Do not use less than 2 gallons of water per 1000 sq ft. If necessary, irrigate thoroughly to incorporate IMIDACLOPRID 75WSP T&O into the upper soil profile.

Refer to use directions specific for FLOWERS and GROUND COVERS concerning additional use directions.

RESTRICTIONS: Do not apply more than 8.6 ounces (0.4 lb of active ingredient) per acre per year.

FOR SOIL APPLICATION TO NON-BEARING FRUIT & NUT TREES, SHRUBS, FLOWERS AND GROUNDCOVERS (Only For Industrial, Commercial Buildings, Residential, and Landscaped Planting Areas) (Including State, National, and Private Wooded and Forested Areas)

TO CONTROL:

- Adelgids Aphids Armored scales (suppression) Asian longhorn beetle Black vine weevil larvae Emerald Ash Borer Eucalyptus longhorned borer Flatheaded borers (including bronze birch and alder borer) Japanese beetles
- Lace bugs Leaf beetles (including elm and viburnum leaf beetles) Leafhoppers (including glassywinged sharpshooter) Leafminers Mealybugs Pine tip moth larvae Plant bug Psyllids

Roundheaded borers Royal Palm Bugs Sawfly larvae Soft scales

Thrips (suppression) White grub larvae Whiteflies

For TREES -

Use the following rates as a function of tree diameter at breast height (DBH):

Apply 1.6 ounces (1 packet) of Imidacloprid 75WSP T&O per 12 to 48 inches of cumulative trunk diameter for tree(s) intended to be treated.

Use the higher rates for trees greater than 15 DBH to control the following pests:

Asian longhorn beetle Emerald Ash Borer Eucalyptus longhorned borer Bronze birch borer Alder borer

To calculate the higher rates divide the cumulative trunk diameter by 12-23 inches.

EXAMPLES OF HOW TO CALCULATE:

To calculate the lower rate:

If you have three trees having DBH of 8, 10 & 14 inches, the total cumulative inches of trunk diameter will be 34 inches (8 + 10 + 16 = 34)

34/48 = .708 x 1.6 fl. oz (1 packet) = 1.13 oz per tree OR 34/24 = 1.417 x 1.6 fl. oz. (1 packet) = 2.27 oz per tree

• If you have a single tree with a DBH of 12 inches, the lower rate range will be:

12/48 = 0.25 x 1.6 oz (1 packet) = 0.4 oz per tree OR 12/24 = 0.5 x 1.6 oz (1 packet) = 0.8 oz per tree

To calculate the higher rate:

 If you have three trees having DBH of 15, 20 & 25 inches, the total cumulative inches of trunk diameter will be 60 inches (15 + 20 + 25 = 60)

> 60/23 = .2.6 x 1.6 fl. oz (1 packet) = 4.17 oz per tree ·OR 60/12 = 5 x 1.6 fl. oz. (1 packet) = 8 oz per tree

If you have a single tree with a DBH of 30 inches, the higher rate range will be:

30/23 = 1.3 x 1.6 oz (1 packet) = 2.08 oz per tree OR 30/12 = 2.5 x 1.6 oz (1 packet) = 4.0 oz per tree

RESTRICTION: Do not apply more than 8.53 oz (.4 lb of active ingredient) per acre per year.

Diameter at Breast Height (D.B.H.) = is measured at 4.5 feet from the ground.

APPLICATION TECHNIQUE:

SOIL INJECTION:

Mix required dosage in sufficient water to inject an equal amount of solution in each hole. For concentrate injectors mix required dose with up to 1 gallon of water per DBH inch. Maintain a low pressure and use sufficient solution for distribution of the liquid into treatment zone. Dilution rate may vary depending on equipment used, tree size and application rate. Refer to the instructions for injector equipment being used for guidance.

- GRID SYSTEM: Make applications in a grid pattern on 2.5 foot centers within the drip line of the tree.
- CIRCLE SYSTEM: Make applications in holes evenly spaced approximately 2 3 feet apart in a circle within the drip line of the tree. Larger trees may require additional application circles.
- BASAL SYSTEM; Make applications into holes evenly spaced around the base of the tree trunk no more than 6 to 12 Inches out from the base.

SOIL DRENCH:

Apply in no less than 10 gallons of water per 1000 square feet as a drench around the base of the tree, directed to the root zone. Any plastic or other barrier that may prevent drench solution from reaching the root zone must be removed.

FOR ALL APPLICATION TECHNIQUES:

- Inject an equal amount of water and solution in each hole.
- Use low pressure and sufficient solution for thorough distribution into the treatment zone.
- Maintain soil moisture for 7 to 10 days.
- Application to trees already heavily infested with borers listed may not prevent the eventual loss of the trees.

RESTRICTIONS FOR TREES:

- Do not use less than 4 holes per tree.
- No Soil Injection Applications Allowed In Nassau or Suffolk Counties of New York.
- Do not apply more than 8.53 oz (.4 lb of active ingredient) per acre per year.

For SHRUBS -

Apply 1.6 ounces (1 packet) of Imidacloprid 75WSP T&O per 24 to 48 foot of cumulative shrub height.

APPLICATION TECHNIQUES:

SOIL INJECTION:

Apply to individual plants using dosage Indicated.

SOIL DRENCH:

Uniformly apply the dosage in no less than 10 gallons of water per 1000 square feet as a drench around the base of the tree, directed to the root zone. Remove plastic or any other barrier that will stop solution from reaching the root zone.

- Mix required dosage in sufficient water to inject an equal amount of solution in each hole.
- Use low pressure and sufficient solution for distribution of the liquid into the treatment zone.
- Maintain soil moisture for 7 to 10 days.

RESTRICTIONS FOR SHRUBS:

- Do not use less than 4 holes per shrub.
- No Soil Injection Applications Allowed In Nassau or Suffolk Counties of N«w York.
- Do not apply more than 8.53 oz (.4 lb of active ingredient) per acre per year.

For FLOWERS and GROUNDCOVERS -

Apply 1.6 ounces (1 packet) of Imidacloprid 75WSP T&O per 8,250 to 11,000 sq ft.

Apply as a broadcast treatment and incorporate into the soil before piling or apply after plants are established. If application is made to established plants, best control is achieved by irrigating after application.

POME FRUITS (For Residential Areas Only)

Includes: Apple, Crabapple, Loquat, Mayhaw, Pear, Pear (oriental), Quince

TO CONTROL:

Aphids (except Wooly apple aphid) Leafhoppers (including glassy-winged sharpshooter) Leafminer Mealybugs* San Jose Scale*

Apply 1.6 ounces (1 packet) per 300 gallons of water OR 2.1 ounces per acre¹ as foliar spray after petalfall is complete.

- For control of rosy apple aphid, apply prior to leafrolling caused by the pest.
- For first generation leafminer control, make first application as soon as petal fall is complete. Greatest leafminer control will result from the earliest possible application. For second and succeeding generations of leafminer, optimal control is obtained from applications made early in the adult flight against egg and early instar larvae. A second application may be required 10 days later if severe pressure continues or if generations are overlapping a single application may result in suppression only.
