IMIDACLOPRID 75WSP T&O will suppress cutworms and chinch bugs.

IMIDACLOPRID 75WSP T&O can be applied on turfgrass in the following sites:

Home lawns
Business and office complexes
Shopping complexes
Multi-family residential complexes
Golf courses
Airports

Cemeteries Parks Playgrounds Athletic fields Sod farms* IMIDACLOPRID 75WSP T&O has adequate residual activity that applications can be made preceding the egg laying activity of the target pests.

Best control is achieved when applications are made prior to egg hatch of the pests and when rainfall or irrigation after application will penetrate vertically in the soil column carrying the active ingredient into the zone where insects are normally located. In order to move the active ingredient through the thatch, irrigate if rainfall does not occur within 24 hours after application.

Apply 1.6 ounces (1 packet per 8,250 to 11,000 sq ft). Make application prior to egg hatch of grabs, billbugs, annual bluegrass weevil, and European Crane Fry to maximize control.

For chinch bugs (suppression) and mole crickets apply 1.6 ounces (1 packet) per 8,250 sq. % For suppression of chinchbugs, make application before the hatching of the first instar nymphs.

For control of mole crickets make application before or during the peak egg hatch period. If adults or large nymphs are actively tunneling, combine applications of IMIDACLOPRID 75WSP T&Q with a remedial insecticide. Follow label instructions for other insecticides when tank-mixing.

Consult your local turf, state Agricultural Experiment Station, or State Extension Service Specialists for more specific Information regarding timing of application.

Application Equipment for Use on Turfgrass

Dilute IMIDACLOPRID 75WSP T&O with enough water to provide adequate volume to promote thorough distribution into the pest zone. Use only accurately calibrated equipment for application to turfgrass. Apply a uniform, coarse droplet spray, using a low pressure setting to eliminate off target drift. Perform calibration on a regular basis to ensure that equipment is distributing product properly.

RESTRICTIONS FOR TURF GRASS:

- Do not exceed a total of 8.6 ounces application (0.4 lb of active ingredient) per acre per year.
- Do not allow this product to contact plants in bloom if bees are foraging in the treatment area.
- Do not mow turf or lawn area, until after adequate irrigation or rainfall has occurred.

APPLICATION TO ORNAMENTALS

IMIDACLOPRID 75WSP T&O can be applied to ornamental plants in commercial and residential landscapes and interior plantscapes. IMIDACLOPRID 75WSP T&O is a systemic insecticide that is transported within the plant system from the roots to upper foliage. IMIDACLOPRID 75WSP T&O must be applied into a growing area of the plant that allows absorption of the active ingredient. Adding soluble nitrogen type fertilizers to the spray solution when appropriate can promote the uptake of the active ingredient.

Application can be made by foliar application or soil applications; including soil injection, drenches, and broadcast sprays. Foliar applications offer locally systemic activity against listed insect pests.

The systemic translocation of active ingredient will be slower when applied to woody plants with soil applications. This delay can take 60 days or longer depending on species and size of plant. To offset this, make applications before anticipated pest infestation.

ANT MANAGEMENT PROGRAMS

Using IMIDACLOPRID 75WSP T&O to control aphids, scale insects, mealybugs and other sucking pests on ornamentals will reduce ant populations because it removes honeydew as a food source. To enhance control of ants, supplement with residual sprays, bait placements or other ant control tactics.

APPLICATION EQUIPMENT FOR FOLIAR APPLICATIONS

IMIDACLOPRID 75WSP T&O mixes readily with water and may be used in many types of application equipment. Add a commercial spreader/sticker promote coverage on hard to wet foliage such as ກໍ່ວູໃຫ້, pine, or ivy.

Apply 1.6 ounces (1 packet) of Imidacloprid 75WSP T&O per 300 gallons of water. Make foliar applications before high pest populations become established. Reapply on an as needed basis.

To control White grub larvae, (such as Japanese beetle larvae, Chafers, Phyllophaga spp. Asiatic garden beetle, Oriental beetle) apply 1.6 ounces (1 packet) per 8,250 to 11,000 sq ft.

For TREES -

Use the following rates as a function of tree diameter at breast height (DBH):

Apply 1.6 ounces (1 packet) of Imidacloprid 75WSP T&O per 12 to 48 inches of cumulative trunk diameter for tree(s) intended to be treated.

You may use the higher rate only for trees greater than 15 DBH to control the following pests:

Asian longhorned beetle Emerald Ash Borer Eucalyptus longhorned borer Bronze birch borer Alder borer

To calculate the higher rates divide the cumulative trunk diameter by 12-23 inches.

EXAMPLES OF HOW TO CALCULATE:

To calculate the lower rate:

■ If you have three trees having DBH of 8, 10 & 14 inches, the total cumulative inches of trunk diameter will be 34 inches (8 + 10 + 16 = 34)

$$34/48 = .708 \times 1.6 \text{ fl. oz } (1 \text{ packet}) = 1.13 \text{ oz per tree}$$

 OR
 $34/24 = 1.417 \times 1.6 \text{ fl. oz. } (1 \text{ packet}) = 2.27 \text{ oz per tree}$

• If you have a single tree with a DBH of 12 inches, the lower rate range will be:

$$12/48 = 0.25 \times 1.6$$
 oz (1 packet) = 0.4 oz per tree OR $12/24 = 0.5 \times 1.6$ oz (1 packet) = 0.8 oz per tree

To calculate the higher rate:

If you have three trees having DBH of 15, 20 & 25 inches, the total cumulative inches of trunk """ diameter will be 60 inches (15 + 20 + 25 = 60)

• If you have a single tree with a DBH of 30 inches, the higher rate range will be:

$$30/23 = 1.3 \times 1.6$$
 oz (1 packet) = 2.08 oz per tree OR $30/12 = 2.5 \times 1.6$ oz (1 packet) = 4.0 oz per tree

RESTRICTION: Do not apply more than 8.53 oz (.4 lb of active ingredient) per acre per year.

Diameter at Breast Height (D.B.H.) = is measured at 4.5 feet from the ground.

APPLICATION TECHNIQUE:

SOIL INJECTION:

Mix required dosage in sufficient water to inject an equal amount of solution in each hole. For concentrate injectors mix required dose with up to 1 gallon of water per DBH inch. Maintain a low pressure and use sufficient solution for distribution of the liquid into treatment zone. Dilution rate may vary depending on equipment used, tree size and application rate. 
