The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Bifenthrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. RESISTANCE MANAGEMENT

For resistance management, please note that IMID-BIFEN 0.15 GC + FERTILIZER contains both a Group 3A and a Group 4A insecticide. Any insect/mite population may contain individuals naturally resistant to IMID-BIFEN 0.15 GC + FERTILIZER and other Group 3A or Group 4A insecticides. The resistant individuals may dominate the insect/mite population if these insecticides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

To delay insecticide resistance, take the following steps:

- Rotate the use of IMID-BIFEN 0.15 GC + FERTILIZER or other Group 3A or Group 4A insecticides within a growing season, or among growing seasons, with different groups that control the same pests.
- Use tank mixtures with insecticides from a different group that are equally effective on the target pest when such use is permitted. Do not rely on the same mixture repeatedly for the same pest population. Consider any known cross-resistance issues (for the targeted pests) between the individual components of a mixture. In addition, consider the following recommendations provided by the Insecticide Resistance Action Committee (IRAC):
 - o Individual insecticides selected for use in mixtures should be highly effective and be applied at the rates at which they are individually registered for use against the target species.
 - Mixtures with components having the same IRAC mode of action classification are not recommended for insect resistance management.
 - When using mixtures, consider any know cross-resistance issues between the individual

- components for the targeted pest(s).
- Mixtures become less effective if resistance is already developing to one or both active ingredients, but they may still provide pest management benefits.
- The insect resistance management benefits of an insecticide mixture are greatest if the two components have similar periods of residual insecticidal activity. Mixtures of insecticides with unequal periods of residual insecticide activity may offer an insect resistance management benefit only for the period where both insecticides are active.
- Adopt an integrated pest management program for insecticide use that includes scouting, uses historical information related to pesticide use, crop rotation, record keeping, and which considers cultural, biological and other chemical control practices.

VEGETATIVE FILTER STRIPS

Construct and maintain a vegetative filter strip, according to the width specified below, of grass or other permanent vegetation between the field edge and nearby down gradient aquatic habitat (such as, but not limited to, lakes; reservoirs; rivers; streams; marshes or natural ponds; estuaries; and commercial fish farm ponds).

Only apply products containing bifenthrin onto fields where a maintained vegetative filter strip of at **least 25 feet** exists between the field edge and where a down gradient aquatic habitat exists. This minimum required width of 25 feet may be reduced or removed under the following conditions:

- For Western irrigated agriculture, a maintained vegetative filter strip of at least 10 feet wide is required. Western irrigated agriculture is defined as irrigated farmland in the following states: WA, OR, CA, ID, NV, UT, AZ, MT, WY, CO, NM, and TX (west of I-35).
 - For Western irrigated agriculture, if a sediment control basin is present, a vegetative filter strip is not required.
- In all other areas, a vegetative filter strip with a minimum width of 25 feet is required, unless the following conditions are met. The vegetative filter strip requirement may be reduced from 25 feet to 15 feet if at least one of the following applies:
 - o The area of application is considered prime farmland (as defined in 7 CFR § 657.5).
 - Conservation tillage is being implemented on the area of application. Conservation tillage is defined as any system that leaves at least 30% of the soil surface covered by residue after planting. Conservation tillage practices can include mulch-till, notill, or strip-till.
 - o A functional terrace system is maintained on the area of application.

- Water and sediment control basins for the area of application are functional and maintained.
- The area of application is less than or equal to 10 acres.

APPLICATION TO TURFGRASS

The use of this product will provide plant nutrients as well as providing control of selected insect pests. IMID-BIFEN 0.18 GC + FERTILIZER can be used for the control of the following soil inhabiting pests of turfgrass:

IMID-BIFEN 0.18 GC + FERTILIZER can be used as directed on turfgrass on golf courses and sod farms.

The active ingredients IMID-BIFEN 0.18 GC + FERTILIZER have sufficient residual activity so that applications for control of subsurface feeders can be made preceding the egg laying activity. The need for an application for control of subsurface feeders can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control of subsurface feeders will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

The active ingredients in IMID-BIFEN 0.18 GC + FERTILIZER have sufficient knockdown and residual activity to provide curative and residual control of surface feeding pests. Applications for control of surface feeding pests can be made when infestations are anticipated based on historical monitoring of the site, previous records or experience, current season adult trapping or presence of insects at economic thresholds as determined by scouting and/or recommendations of local State extension personnel or other qualified specialists.

Applications should not be made when turfgrass areas are waterlogged or the soil is saturated with water. Adequate distribution of the active ingredient cannot be achieved when these conditions exist. The treated turf must be in such a condition that the rainfall or irrigation will penetrate vertically in the soil profile. Total amount applied cannot exceed a total of 400 lb (0.5 lb of imidacloprid, 0.4 lb of bifenthrin) per acre per year.

APPLICATION EQUIPMENT

Apply IMID-BIFEN 0.18 GC + FERTILIZER uniformly over the area being treated with normally used granular application equipment. Both drop-type and rotary-type spreaders may be used to apply IMID-BIFEN 0.18 GC + FERTILIZER. Avoid the use of spreaders that apply the material in narrow, concentrated bands. Calibrate application equipment prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly and accurately.

¹Imported Fire ants: IMID-BIFEN 0.18 GC + FERTILIZER may be applied as a broadcast treatment up to 11.4 lb. per 1,000 sq. ft. and/or as a mound treatment by applying 1 cup of IMID-BIFEN 0.18 GC + FERTILIZER per mound and then drenching the mound with 1 to 2 gallons of water. The mounds should be treated with sufficient force to break their apex and allow the insecticide to flow into the ant tunnels.

²Mole crickets: For maximum effectiveness, apply IMID-BIFEN 0.18 GC + FERTILIZER as a broadcast treatment at 5.7 lb. per 1,000 sq. ft. prior to or during the peak egg hatch period. For application when both adults and/or large nymphs are present and actively tunneling, irrigate prior to application if soil is dry and apply 5.7 lb. per 1000 sq. ft. Rainfall or additional irrigation within 24 hours after application will improve effectiveness of IMID-BIFEN 0.18 GC + FERTILIZER. For heavily infested mole cricket areas, use a single seasonal application rate of 400 to 500 lb. per acre.

³Pillbugs and sowbugs: For heavy infestation use 500 lbs per acre (11.4 lbs per 1,000 sq. ft.) of IMID-BIFEN 0.18 GC + FERTILIZER.

Consult your local State Agricultural Experiment Station or State Extension Turf Specialists for more specific information regarding timing of application.

NOTE: For optimum control, irrigation or rainfall should occur within 24 hours after application to move the active ingredient through the thatch. Do not apply more than 500 lb product per acre (0.5 lb of imidacloprid active ingredient, 0.4 lb bifenthrin) per acre per year. Avoid mowing turf or lawn area until after irrigation or rainfall has occurred so that uniformity of application will not be affected.

In New York State, this product may NOT be applied to any grass or turf area within 100 feet of a water body (lake, pond, river, stream, wetland, or drainage ditch).

In New York State, do make a single repeat application of IMID-BIFEN 0.18 GC + FERTILIZER if there are signs of renewed insect activity, but not sooner than two weeks after the first application.
